JMCBO Universal Release of Liability

IN CONSIDERATION of being given the opportunity to participate in any rowing activity, including, but not limited to, scheduled, supervised club activities, and affiliated regattas, until the end of the present school year, I, for myself, my personal representatives, assigns, heirs, and next of kin:

ACKNOWLEDGE, agree and represent that I understand the nature of Rowing Activities, both on water and land based ("Rowing Activities"), and that I am qualified, in good health, and in proper physical condition to participate in such Rowing Activities.

FULLY UNDERSTAND that:

- (a.) ROWING ACTIVITIES INVOLVE RISKS AND DANGERS of serious bodily injury, including permanent disability, paralysis, and death ("Risks");
- (b.) these Risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the Rowing Activity, the condition in which the Rowing Activity takes place, or the negligence of the Releasee(s) named below;
- (c.) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in the Rowing Activity.

AGREE AND WARRANT that: I will examine and inspect each Rowing Activity in which I take part and that, if I observe any condition which I consider to be unacceptably hazardous or dangerous, I will notify the proper authority in charge of the Rowing Activity and will refuse to take part in the Rowing Activity until the condition has been corrected to my satisfaction.

HEREBY RELEASE, discharge, and covenant not to sue the James Madison Crew Booster Organization ("JMCBO"), as Releasee, including but not limited to its administrators, directors, agents, officers, volunteers and employees, any participating regatta organizers, any sponsors, advertisers, and if applicable, owners and lessors of premises, on which the Activity takes place, (each considered one of the Releasees herein) from all liability, claims, demands, losses or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasee or otherwise, including negligent rescue operations; and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement, I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE AND HOLD HARMLESS each of the Releasees from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as a result of such claim, to the fullest extent permitted by law. I, and I alone, am responsible for my personal health and safety and the personal property that I bring with me. I am solely responsible for my medical expenses and decisions with respect to my care. I give my consent in the event of injury to any emergency medical aid, anesthesia, or operation deemed necessary by the attending physician.

I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely and without any inducement or assurance of any nature. I intend my signature on this agreement to be a complete and unconditional release of all liability to the greatest extent allowed by law, and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.

2009-2010 PARTICIPATION CONTRACT

Part I. Code of Behavior:

All James Madison High School (JMHS), students and their parents who participate in Crew activities, acknowledge that they are representing JMHS. By signing this Participation Contract, both the student and parent(s) agree to abide by the James Madison Crew Booster Organization's (JMCBO) Code of Behavior at all times during formal and informal Crew activities. Any inappropriate conduct of an individual rower, or group of rowers, will be dealt with and resolved at the coaches' discretion. Removal from the team for inappropriate conduct forfeits the right to any refunds of dues.

Students are expected to:

- Read and understand all policies, commitments and requirements as specified on the JMCBO Handbook
- Dress, act and speak as mature, courteous and considerate young men and women.
- Treat all teammates, opponents, coaches, officials, parents and volunteers with respect.
- Participate fully in all aspects of training and racing.
- Travel safely to, and arrive on time for all practices, meetings, regattas and other scheduled events.
- Obey rules set forth by bus drivers and parent drivers.
- Take prudent measures to safeguard your person and your property.
- Adhere to the Fairfax County Public School policy regarding the use and/or possession of alcohol, tobacco and drugs.
- Comply with VHSL and Crew program eligibility rules, including maintaining passing grades to participate.
- Comply with the James Madison High School Extracurricular Participation Policy .

Parents are expected to:

- Read and understand all policies, commitments and requirements as specified on the JMCBO Handbook
- Treat all students, opponents, coaches, officials, parents and volunteers with respect.
- Support the coaching staff and the JMCBO by ensuring that your child meets the Student's Expectations listed above.
- Actively participate in JMCBO fundraising, committee and volunteer opportunities.
- Complete and submit all required forms by the deadlines requested.
- Adhere to the JMCBO financial requirements set forth in the current edition of the Team Handbook.
- Be supportive of the team by accepting coaching decisions.

Part III. Permission to Participate:

The signature of at least one parent on this Participation Contract grants permission for the student to participate in all James Madison Crew Booster Organization (JMCBO) activities. By signing this contract, the parent understands that travel may be by motor coach, school bus, or automobile and that JMCBO activities may expose their child to the risk of injury or death, and that participation involves activities off school property, where neither Fairfax County Public Schools nor its employees or chaperones will have any responsibility for the condition of non-school property.

Parents(s) authorize coaches and chaperones to supervise and direct their child and in the event where necessary, to obtain for their child the medical treatment the coaches and chaperones deem necessary. Licensed physicians or health care professionals are authorized to provide necessary medical treatment for the child upon the request of a coach or chaperone, and parent(s) accept full financial responsibility for such treatment.

2009-2010 Transportation Liability Waiver
